ABSTRAK

Latar Belakang : Penerapan protokol kesehatan di masa pandemi Covid-19 diwajibkan bagi seluruh lapisan masyarakat agar terhindar dari paparan Covid-19 serta khususnya kalangan remaja yang saat ini banyak ditemukan kasus konfirmasi paparan Covid-19

Tujuan Penelitian : Mengetahui faktor penghambat kepatuhan remaja untuk tertib protokol kesehatan di Desa Karangrejo

Metode Penelitian : Penelitian ini menggunakan metode kualitatif dengan pendekatan fenomenologi serta menggunakan teknik *purposive sampling*, responden merupakan remaja domisili Desa Karangrejo Kabupaten Gresik. Instrumen penelitian adalah peneliti sendiri dengan bantuan pedoman wawancara, alat perekam suara, serta dokumentasi

Hasil Penelitian : Remaja masih belum mempunyai kesadaran penuh akan pentingnya protokol kesehatan, minimnya upaya pemerintah dalam memberikan sosialisasi terkait dengan protokol kesehatan, tidak adanya pemberlakuan sanksi terhadap para pelanggar protokol kesehatan serta pemanfaatan sarana prasarana penunjang protokol kesehatan yang kurang dimaksimalkan oleh para remaja.

Kesimpulan : Ketidakepatuhan remaja disebabkan karena masih belum terbiasa dengan penerapan protokol kesehatan, rasa kurang nyaman dalam berinteraksi jika berjaga jarak. Upaya sosialisasi mengenai pentingnya protokol kesehatan dari pemerintah Desa Karangrejo yang belum optimal dan tidak adanya penerapan sanksi yang berarti terhadap para pelanggar protokol kesehatan. Serta tidak maksimalnya pemanfaatan sarana prasarana yang ada oleh remaja

Rekomendasi Penelitian : Menumbuhkan kesadaran remaja agar dapat tetap menerapkan protokol kesehatan selama masa pandemi, bagi pemerintah Desa Karangrejo agar memberikan sanksi terhadap pelanggar protokol kesehatan guna memberikan efek jera.

Background : *The implementation of the protocol in future health pandemic Covid-19 required for the whole society in order to avoid papaparan Covid-19 and especially among teenagers who today are found confirmed cases of exposure Covid-19*

Objective : *To identify factors inhibiting adolescent adherence to orderly health protocols in Karangrejo Village*

Research Methods : *This study used a qualitative method with a phenomenological approach and used purposive sampling technique, the respondents were teenagers domiciled in Karangrejo Village, Gresik Regency. The research instrument is the researcher himself with the help of interview guides, voice recorders, and documentation of*

Research results : *Adolescents still do not have full awareness of the importance of health protocols, the lack of government efforts in providing socialization related to health protocols, the absence of sanctions for violators of health protocols and the use of infrastructure supporting health protocols that are not maximized by teenagers.*

Conclusion : *Adolescents' disobedience is caused because they are still not familiar with the application of health protocols, they feel uncomfortable in interacting if they keep their distance. Socialization efforts regarding the importance of health protocols from the Karangrejo Village government are not yet optimal and there is no implementation of significant sanctions against health protocol violators. As well as not optimal utilization of existing infrastructure by adolescents*

Research Recommendations: *Raising awareness of adolescents so that can continue to apply health protocols during the pandemic, for the Karangrejo Village government to impose sanctions on violators of health protocols in order to provide a deterrent effect.*
